Leadership Report

In 2021, we continued to experience the ebbs and flows of COVID and it continued to have a significant impact on all organizations including Big Brothers Big Sisters of Greater Halifax.

This year reaffirmed for me that our organization is filled with some of the most positive, dedicated and talented individuals I know. Despite all the challenges that COVID presented, our organization carried on throughout the pandemic as our staff and volunteers continued to focus on providing extraordinary service to children, youth and their families. The Service Delivery team managed to create 63 new matches and support 222 existing matches in 2021 even when faced with the tremendous challenges of lockdowns and social distancing. These mentoring relationships often result in positive, life-changing effects including social emotional competence, mental health and well-being, and educational engagement. Life-long friendships are not unusual. This was an outstanding accomplishment given the trying circumstances of the past year.

At the same time our Fund Development team and our many volunteers worked tirelessly during 2021 to ensure our financial stability. The Fund Development team developed new and innovative ideas to keep our foundations, individual donors, and corporations engaged. This included events such as HaliFACTS Trivia Challenge, the Big Tri, Golf for Kids Sake etc. Likewise our ReNew team did a great job of successfully managing through disruptions in operations throughout the past year and are now back up and running and providing much needed revenue to our organization. We believe foundations, individual donors, corporations and the Department of Community Services invest in Big Brothers Big Sisters because they know this is an outstanding return on investment, and in a year of continued uncertainty your support was greatly needed and appreciated. Your financial support along with the Federal Government wage subsidies allowed us to continue operations uninterrupted over the past year. Thank you!

In January of 2021, our long-serving Executive Director, Carol Goddard retired after 50 years of dedicated leadership to the organization. Under Carol's guidance, the agency grew to serve more youth, pioneered programs and started a social enterprise to help fund the core work. Illustrating Carol's depth of meaningful relationships throughout the organization, over 100 people attended her virtual retirement party, with guests from across the country. Stepping in to fill Carol's shoes, Shelda Cochrane and Jonathan Leard have completed their first year in their co Executive Director roles. In seeing them in their new roles, the organization is fortunate to be led by them. They put our Bigs and Littles first in all that they do and in each and every decision they make.

Things are slowly getting back to normal although it will be a "new" normal for some time. This will mean significant financial challenges going forward. With this in mind, we have to reimagine how we work, how we fundraise and how we spend. That's why it is more important than ever that individuals, corporations, foundations and government continue supporting us financially so we can continue to do this important work with youth in our community. I know a number of you have stepped up already and we are extremely thankful.

With this year being my first year as Chair, I of course had big shoes to fill, succeeding our past Chair, Grant Black. I am very thankful for Grant's support and guidance as I stepped into my new role. I am also thankful to be surrounded by an amazing Board who have supported me and empowered me in my new role. Lastly, I'd like to thank, our tremendous staff and all our volunteers for your hard work and dedication to the youth in our community. I know we make a difference.

Treasurer's Report

Our theme this year is centered around resilience through intentional mentoring. Resilience is defined as the capacity to recover quickly from difficulties; toughness. I am incredibly proud to report on the strength and agility of this team and their capacity to quickly recover.

2021 brought with it many similar challenges to 2020 for our organization. We were consistently shifting and changing plans, and we were unable to have confidence in hosting in-person gatherings or fundraisers. Our biggest event of the year, Bowl for Kids' Sake, was once again sidelined, leaving us thousands of dollars short of our typical budgeted amounts. As Safia mentioned in her report, the team valiantly pivoted, hosting new events, like the HaliFACTS Trivia Challenge, and our biggest Golf for Kids Sake in recent memory. Kudos to the team because it was not without lots of hard work! I cannot say enough about our staff at BBBS of Greater Halifax and ReNew Crew. They displayed exemplary performance throughout the year, showing great resilience and toughness through all the tribulations of the year.

I want to thank the many supporters of Big Brothers Big Sisters of Greater Halifax. Our board is consistently focused on ensuring each dollar obtains its best return to ensure that our youth is well supported, and we are achieving our mandate. Thank you as well to supporters of our ReNew Crew, as our social enterprise was able to bounce back to a strong line item on our financial statements.

I continue to be inspired by the work that Big Brothers Big Sisters of Greater Halifax accomplishes year after year to mitigate the negative impacts of social isolation on our youth and exemplify resilience through intentional mentoring daily.

Overall in terms of financial performance, 2021 was a successful fiscal year at BBBS of Greater Halifax. Once again, our signature Bowl for Kids Sake, along with other fundraising events were cancelled, however with the help of specific COVID funding, as well as the Canada Emergency Wage Subsidy, we were able to continue operations. Our financial performance, as outlined in our 2021 Audited Financial Statements tell the story of a resilient organization, with a healthy cash balance, low debt and payables, and only a manageable net loss before other income, grants and subsidies.

An overview of significant financial line items for 2021:

Total revenue increased by 13% (\$178,576) to \$1,516,953 (2020 – \$1,338,377), with lower Foundation revenue (-\$109,755) as compared to 2020, however, higher amounts in earned revenue (\$224,767) for ReNew Crew, and miscellaneous revenue (\$37,345)

Total expenses held steady (-0.2%) (-\$3,680) to \$1,527,194 (2020 - \$1,530,874).

Prior to Government grants and subsidies, we ended the year in a negative financial position with a deficiency of expenses over revenue in the amount of -\$10,241. However, thanks to the CEWS and other Government subsidies, all in, we are reporting a net income of \$156,211, an increase of 12% over 2020 (\$129,526).





ReNew Crew - Chair Report

Big Brothers Big Sisters Halifax Regionality Municipality Foundation (ReNew Crew)

ReNew Crew is a 100% charity owned and locally operated social enterprise, providing a service to residents through collection of donated clothing, other textiles, and small household goods. These donations are resold to our corporate partner, Value Village and the net earned revenue is used to support critical mentoring programs for children and youth facing adversity right here in the HRM.

Through fiscal 2021 the impacts of the COVID-19 global pandemic continued to challenge our business. Despite the operating environment our ReNew Crew team remained focused and responded to the challenges presented with a solution driven mindset.



The strength of our management team paired with the team's ability to think creatively allowed our business to survive. As we begin to look at the potential headwinds and challenges that remain ahead we are confident our team's preparation and careful strategic planning over the last two fiscal periods have put us in a position to succeed in a post-COVID-19 operating environment. This includes a significant clean-up of our donor registry, implementation of new technology, and rollout and expansion of new collection bins.

In 2021 our team managed top line revenue of \$887,065 (2020 - \$662,298) which after expenses contributed a net profit of \$185,714 (2020 - \$22,047) and a transfer to Big Brothers Big Sisters of Halifax of \$110,000 (2020 - \$52,500). On top of remaining profitable over the last year we are also proud to have kept over 1.5 million pounds of cloth and other reusable goods out of landfills while at the same time keeping the people in our local community employed.

We wanted to take a moment to thank all of the generous supporters of ReNew Crew, past, present and future, as your donations have helped to improve the lives of local families, contributed to the economy and have helped strengthened our community.

A Lifetime of Friendship





40+ Years of Friendship

In 1977, gym teacher Phil O'Hara became a volunteer mentor with Big Brothers Big Sisters. Neither he nor 11 year old Brad Crossley knew how vital their connection would become over the next four decades.

"By the time I was 10 years old, I had lived on 10 different streets, apartments and went to different schools for numerous reasons. Having a man or a father figure in a boy's life is really important," said Brad, "and my mother recognized I would benefit from having another supportive adult around."

Phil understood that need and stepped up to the plate. "I think that Brad really needed somebody to trust and be there for him, and I was ready to be that person."

Coincidentally, prior to their match, Brad had been Phil's student at the school where Phil taught. "He really stood out as not only being athletic, but funny, charismatic and a leader among his peers," said Phil.

Over the years Phil taught Brad how to rock climb and drive a car. They stood in each other's wedding and even named their sons after each other. In 2017, Phil was inspired by Brad to begin cycling. This led to him losing a significant amount of weight and achieving a healthier lifestyle.

Two years later, Phil was diagnosed with esophageal cancer and by the summer of 2021 was classified as a palliative care patient with stage 4 cancer, with no chance of survival. Through it all, Brad was Phil's constant companion and biggest pillar of strength.

In the fall of 2021, the effects of cancer were evident. Phil had difficulty with balance and walking. Throughout his illness, he was candid about the fact he felt fragile and weak. Despite these serious challenges, Phil & Brad registered to run the 10k race in the Scotiabank Bluenose Marathon in Halifax in November 2021.

It was an incredible feat of friendship and tenacity as they trained and prepared for the run. Phil started and ended the race on his feet, with Brad and a myriad of other friends and supporters pushing him the rest of the way in an adaptive wheelchair. When they crossed the finish line, the crowd erupted in cheers, and a number of media were on hand to record the event. Phil was overwhelmed with the support and said it was as close to "nirvana" as he could imagine. On top of achieving a bucket list goal, Phil, Brad and their team raised \$13,000 in donations for Big Brothers Big Sisters.

Just three short months after this epic finish line moment, Phil passed away, surrounded by loved ones. His legacy of living life to the fullest and caring deeply for those around him will be carried on by those who had the privilege to know him. We're thankful for the incredible time and support he gave to Big Brothers Big Sisters, and thank his family for sharing him with us.
